**Dr. Natasha K. Bowen** is a professor at the College of Social Work at Ohio State University. Her research and community-engaged work focus on helping schools assess and address social environmental threats to student success, particularly the success of marginalized racial/ethnic minority students. She is currently revamping and updating a website that offers school practitioners free multi-domain assessments for middle, high, and elementary school students and resources for evidence-based practice. Dr. Bowen also teaches PhD students statistics and structural equation modeling.



**Stephanie Carnes** is the founder of Create Cultural Competence, LLC, a New York-based consultancy. In this role, she works with school districts and community organizations to fine-tune their ability to serve immigrant students and clients. She is a trauma-focused licensed clinical social worker (LCSW) and speaks fluent Spanish. She frequently presents at national conferences and workshops, most recently for the NASW-NY and NYSSBA, on topics related to cultural competence, Latinx immigrants, and trauma treatment. She holds an MSW, an LL.M. Master's of Law in International Human Rights Law, and is currently pursuing her doctorate at SUNY Albany's School of Social Welfare, where she focuses on Latinx adolescent identity development, resilience, and xenophobia.



**Dr. Annette Clayton** is currently an Assistant Professor and the Internship Director for the Baccalaureate Social Work Program at Virginia Wesleyan University in Virginia Beach Virginia. Her previous teaching experiences include two years as an Assistant Professor of Social Work at the United Arab Emirates University and adjunct teaching for Virginia Commonwealth University and George Mason University. Before entering academia full time, Dr. Clayton worked as a School Social Worker for many years and was the Lead School Social Worker for Newport News Public Schools for five years. Dr. Clayton completed her undergraduate education at Howard University where she majored in Psychology and minored in Zoology. She earned her MSSW degree from The University of Texas at Austin and completed her PhD studies at Virginia Commonwealth University. Dr. Clayton's scholarship thus far has primarily

focused on school social work practice, the overarching issue of practice efficacy, and the influence of risk and protective factors on adolescents' educational outcomes. In addition to presenting at numerous state and national conferences, Dr. Clayton has published manuscripts in *Children & Schools*, *Affilia: Journal of Women and Social Work*, and the *Journal of African American Studies*.



**Dr. Brenda Coble Lindsey** is a Teaching Full Professor and Chair of the Professional Educator License-School Social Work Program at the University of Illinois at Urbana-Champaign. Her teaching and research interests focus on how school social workers an integrate evidence-based interventions in their practice. Dr. Lindsey has served as a board member of the School Social Work Association of America, Illinois Association of School Social Workers, and is Chair of the School Social Work for NASW.



Anne Contreras, MACP, MFTi is Director of Programs and a national trainer for Pure Edge, Inc. She has twenty years of school social work experience in both secondary and elementary schools between Loudoun County Public Schools and Fairfax County Public Schools. Currently, she is the Coordinator of Social Work Services in Fairfax County Public Schools since 2014. She previously worked in FCPS social work office leadership as a Program Manager and a social worker supervisor, providing program development, management, and supervision to school social workers. During her years in FCPS social work leadership, she has assisted with the development of EBP interventions in schools and tracking aggregate intervention outcome data, program

development and implementation of three community schools and coordinates system-wide initiatives in response to student mental health needs, and school-based trainings around mental health and social-emotional learning. the ability to advocate for themselves in ways that are safe and productive school setting. Wendy collaborates works with classroom teachers and other school staff to help refine their trauma-informed universal classroom strategies and supports, along with managing their own self-care.



**Quyen Duong** is a licensed clinical social worker serving as a Student Services Specialist with the Virginia Department of Education (VDOE). She provides technical assistance to Virginia local school divisions to enhance the capacity of school social workers to address social, emotional, mental health, behavioral, and familial needs.
